PARKS AND PUBLIC PLACES

IT IS ENACTED AND ORDAINED by By-Law No.
1697, concerning curfews in Parks and Public Places as
follows:

ARTICLE 1. For the interpretation of the
present By-Law, the word "Parks" shall mean all parks, play-
grounds, squares, green areas, public places, not including
streets and sidewalks, park buildings and their equipment,
situated within the limits of the Cité de Côte Saint-Luc
and belonging to the municipal corporation.

ARTICLE 2. All parks shall be under the control of the City Council, through the City Manager or his representatives, except in matters of peace and order which are the responsibility of the Montreal Urban Community Police Department.

ARTICLE 3. All parks shall be closed to the public between 11:00 o'clock in the evening and 7:00 o'clock the next morning, except on special occasions and to such extent as may be authorized by the City Council. Anyone who is found in a park while the same is closed to the public and who cannot justify his presence therein is liable to the penalty provided in Article 4 of the present By-Law.

ARTICLE 4. Whosoever shall contravene any of the provisions of this By-Law shall be liable to a fine, with or without costs, and in default of immediate payment of said fine or of the said fine and costs to imprisonment, the amount of such fine and the term of such imprisonment to be fixed at its discretion by the Court of competent jurisdiction in virtue of the charter which shall hear the case, but such fine shall not exceed FIVE HUNDRED DOLLARS (\$500.00) and the term of imprisonment shall not be for a period of more than two calendar months, said imprisonment, however, to cease at any time before the expiration of the term fixed by Court upon payment of the said fine or of the said fine and costs, as the case may be.

ARTICLE 5. The present By-Law shall come into force according to Law.
