N U I S A N C E BY - L A W

At the regular monthly meeting of the Council of the Municipality of the Town of Cote St. Luc, held in the Council Chambers, 8100 Cote St. Luc road, on Tuesday the fifth day of August 1952, and at which were present:

His Worship the Mayor Mr. John H. Fyon, and Messrs. the Aldermen Harry Rand, A. Edgar Davies, G. Harry Robinson, August H. Andrea, Edward J. Kirwan and Walter Silverson.

Our legal Advisor Me. Emé Lacroix Q. C. was also present.

His Worship the Mayor Mr. John H. Fyon, occupied the Chair and Mr. G. L. Hooker, acted as Secretary.

AND RESOLVED: *Unanimously.*

THAT IT BE ENACTED AND ORDAINED by a By-law of the Town Council and it is hereby enacted and ordained as follows:

ARTICLE 1. The emission of sparks, cinders, soot or smoke from chimneys and other sources, within the municipality, shall constitute a nuisance.

ARTICLE 2. The ringing of bells and chimes, the blowing of whistle and the making of other noises, the ringing of bells and whistling of locomotives and the discharge of steam, cinders, sparks and smoke therefrom shall constitute a nuisance.

ARTICLE 3. The throwing or depositing of ashes, paper, refuse, offal, dirt, garbage or any similar matters in the street, alley, yard, public ground or square or municipal stream shall constitute a nuisance.

ARTICLE 4. The sale of any articles whatsoever in the streets and public places shall constitute a nuisance.

ARTICLE 5. The exhibition or carrying or distribution of banners, placards, advertisements or handbills or other articles in or upon streets, alleys, sidewalks and public places shall constitute a nuisance;

ARTICLE 6. The obstruction or encroachment upon the sidewalks, streets, alleys and public grounds, and the encumbering of the same with vehicles or any other things shall constitute a nuisance.

ARTICLE 7. The use of places as dumps for discarded automobiles shall constitute a nuisance.

ARTICLE 8. Any building or part of building or lot or part of lot, being used to store, manufacture, process any waste paper, metal, clothes, rags or any waste good shall constitute a nuisance.

ARTICLE 9. It shall be illegal, unlawful and prohibited to constitute any of the above mentioned nuisances in the Municipality.

ARTICLE 10. Any person contravening to the present By-law shall be liable to a fine not exceeding forty (\$40.00) dollars and the costs and, in default of payment of such fine and costs, within the fifteen (15) days from the delivery of the judgment, shall be liable to an imprisonment, which shall not last longer than one month.

If the infringement to the present By-law is continuous, such continuity shall constitute, day by day, lacking good faith, a separate offence.

In all cases, the imprisonment above mentioned shall cease as soon as the fine and the costs shall have been paid.

ARTICLE 11. The present By-law shall come into force according to the Law.
