BY-LAW TO AMEND BY-LAW NO. 921
REGULATING NOISE IN THE CITY OF
CÔTE SAINT-LUC

It is hereby enacted and ordained by By-Law 2159 entitled "BY-LAW TO AMEND BY-LAW NO. 921, REGULATING NOISE IN THE CITY OF CÔTE SAINT-LUC" as follows:

ARTICLE 1. By-Law 921 entitled "By-Law regulating noise in the City of Côte Saint-Luc" as amended from time to time, is hereby further amended as follows:

Article 1-1.

Article 3 of By-Law 921 is repealed and replaced by the following:

Between 9 o'clock in the evening and 9 o'clock in the morning on Saturdays, Sundays and statutory holidays, and between 9 o'clock in the evening and 7 o'clock in the morning on all other days, at any place in the City, it shall be prohibited to carry out or cause to be carried out any works in connection with the construction, re-construction, alteration or repairing of any building or structure.

Between 10 o'clock in the evening and 7 o'clock in the morning, at any place in the City, it shall be prohibited to carry out or cause to be carried out any works in connection with repairing of motor vehicle, steam boiler, steam engine or other engine or machine whatsoever.


However, the City Council under special circumstances may grant permits for the carrying out of the above works, within the respective above-mentioned time periods.

ARTICLE 2. The present By-law shall come into force according to law.
