
IT IS HEREBY ORDAINED AND ENACTED by By-Law 1436,
entitled "BY-LAW TO AMEND ARTICLE 5 OF BY-LAW NO. 267, OF THE
CITY, ENTITLED "BY-LAW CONCERNING DOGS" AND REPEALING BY-LAW
NO. 383", as follows:

ARTICLE 1. By-Law No. 267, is hereby amended by
replacing Article 5 of said By-Law with the following:-

"ARTICLE 5. Dogs shall be kept on a leash
throughout the year. The Officer-in-Charge
of that Sector of the Montreal Urban
Community Police Force, which includes Côte
Saint-Luc, any policeman under his authority,

I, the undersigned City Clerk, of the City of Côte Saint-Luc, hereby certify ON MY OATH OF OFFICE, that I have posted By-Law No. 1436, for municipal purposes, in the Office of the City and have inserted it in local newspapers in both English and French, to the effect that said By-Law was available for examination at my Office.




or the official Dog Catcher of the City of Côte Saint-Luc, designated as such from time to time by Resolution of the Municipal Council, shall pick up all dogs wandering at any time of the year in the municipality, with or without the identity tag provided by the present By-Law, and carry them to a place designated by Council from time to time, to receive them."

ARTICLE 2. By-Law No. 383 is hereby repealed.

ARTICLE 3. The present By-Law shall come into force according to Law.
