It is enacted and ordained by By-Law 110-1 entitled: "*By-Law 110-1, amending traffic By-Law 110 in the territory of Côte Saint-Luc, to delineate policies and procedures for overnight parking permit holders in high density areas in the territory of Côte Saint-Luc*" as follows:

Traffic By-law No. 110 in the territory of Côte Saint Luc is hereby amended with the following articles:

Article 1: A vehicle owner is hereinafter authorized to park overnight in the territory of Côte Saint-Luc if the following conditions are met:

- (i) In designated "high density" areas so identified by Council, more particularly in sectors comprised of multi-family dwellings, namely apartment buildings;
- (ii) The owner fulfils all of the conditions delineated in the parking permit application annexed hereto as Annex A to form an integral part hereof as if cited at length herein. More particularly, the applicant must provide proof under the form of an attestation that there is insufficient exterior or interior parking space available to the occupants of the building or residence. A false declaration would revoke the permit;
- (iii) The permit application is signed and authorized by the Division Chief of Public Security and is valid for a period of no more than twelve (12) months;
- (iv) The applicant has to pay a monthly fee of \$30.00.

Article 2: This by-law shall come into force according to law.


