IT IS ORDAINED AND ENACTED by By-Law No. 1798, entitled «BY-LAW TO FURTHER AMEND ARTICLE 13 OF BY-LAW 110, ENTITLED 'BY-LAW RELATING TO TRAFFIC AND PUBLIC SAFETY', TO REGULATE THE PARKING IN AREAS RESERVED FOR HANDICAPPED PERSONS'», as follows:

By-Law 110, entitled "BY-LAW RELATING TO TRAFFIC AND PUBLIC SAFETY", as amended from time to time, is hereby

further amended as follows:

ARTICLE 1. Article 13 of By-Law 110, as amended, is hereby further amended by adding, after paragraph (7), the following:


" (8) An area reserved for the parking of vehicles operated by a handicapped person, unless a valid sticker issued for this purpose, by the Cité de Côte Saint-Luc, or any other municipality, is affixed and visibly displayed on the vehicle.

Areas reserved for the parking of vehicles operated by a handicapped person shall be marked by a sign containing the logo attached to the present By-Law as Annex "A".

The conditions under which the City shall issue a special sticker referred to in the first paragraph of sub-section (8) are contained in Annex "B" of the present By-Law."

ARTICLE 2. The present By-Law shall come into force according to Law.



ANNEX "B"

- A) The special sticker is issued to every handicapped person who applies for it, pays the required fee, and furnishes the following documents:
- (i) A Medical Certificate dating back no more than two years, attesting that the applicant does not have the use of his lower limbs or that he only has limited use of them and must use a prosthetic or orthopedic device to get around;
  - (ii) The applicant's Driver's License; and
  - (iii) The Registration Certificate for the vehicle operated by the applicant.
- B) The stickers are issued annually and expire on the 1st day of January of each year.
- C) The required fee shall be fixed by Council resolution.
