IT IS ENACTED AND ORDAINED that By-Law No. 2142 entitled "BY-LAW TO FURTHER AMEND BY-LAW 110 CONCERNING TRAFFIC AND PUBLIC SAFETY, AS AMENDED, BY INCREASING THE FINE STIPULATED THEREIN FOR ILLEGALLY PARKING IN AN AREA

ARTICLE 1. Schedule 'D' referred to in Article 2.3 of By-Law 110, as amended by By-Laws 1695, 1853, 2012, 2116 and 2130, is hereby further amended by replacing the 18th line thereof, under the table of fines, by the following:

"A-136 13 Parking in handicap zone \$100.00"


ARTICLE 2. The second paragraph of Article 43 of By-Law 110, as amended by By-Laws 200, 1640, 1695, 1853, 2012, 2116 and 2130, is hereby further amended by replacing the 18th line of the list of fines, by the following:

"13-8 Parking in handicap zone \$100.00"
