URBAN DEVELOPMENT - AUTHORIZATION TO SUBMIT A REQUEST FOR FINANCIAL SUPPORT FOR A STREETSCAN SIDEWALKS ANALYSIS IN THE CITY OF CÔTE SAINT-LUC

WHEREAS the City of Côte Saint-Luc ("City") wishes to perform an analysis of the condition of its sidewalks by using an advanced technology namely, StreetScan;

WHEREAS funds for this type of project are available under the Federation of Canadian Municipalities' *Municipal Asset Management Program*;

WHEREAS the City of Côte Saint-Luc (the "City") was advised on Friday, April 20, 2018 that Les Cours Parkhaven Inc. and 9264-8476 Québec Inc. were illegally building or illegally authorizing construction at 5792 Parkhaven Avenue in the City of Côte Saint-Luc as no permit fees were paid and building plans still require approval;

WHEREAS an injunction is required to ensure that all construction works being performed currently cease;

WHEREAS a further mandate is required to authorize the demolition of any nonconforming structures should circumstances so warrant;

THAT Council further authorizes the City to reimburse its Attorneys all reasonable legal expenses related to this legal mandate and a Treasurer's Certificate will be procured if/when necessary once these said expenses become known;

THAT Council further authorizes the Director of Legal Services to take any further action in damages against Les Cours Parkhaven Inc. and 9264-8476 Québec Inc. as well as their insurers to recover any amounts disbursed (including legal fees) as a result of this incident."

AND RESOLVED:

"THAT the Côte Saint-Luc City Council hereby authorizes the following additional Elected Officials to officiate and solemnize marriages and civil unions within the territory of Côte Saint-Luc thus authorizing the *Directeur de l'état civil* to designate them for said purpose, said members of Council listed as follows:
