**Slope Requirement**

Homes built after 1974 in Côte Saint-Luc were not permitted to have a steep driveway with a slope of 10 percent or greater (bylaw 1364). Therefore the chance of your home having a 10 percent slope or greater is very unlikely. If you have nowhere else to park your vehicle except for a driveway with a slope of 10 percent or greater, you may be eligible for an overnight parking permit. If you select 'Yes' below, a city inspector will measure the slope of your driveway and **you must pay a \$35\* fee when you submit this form.**

Do you want the City of Côte Saint-Luc to measure the slope of your driveway to determine if it is greater than 10 percent?

- **NOTE:** *The inspection fee will not be reimbursed. However, if your slope is 10 percent or greater and you buy a permit, we will deduct \$35 from your bill. Please make cheque payable to “City of Côte Saint-Luc”.*

**\*\* NOTE:** *If your slope was measured on or after 2007, the city will not re-measure it and you will not be charged and do not need to include payment.*

### **Documents to Include**

If you are an owner:

- (i) a photocopy of the vehicle registration, (ii) one of the following: the applicant's driver's license, utility bill, formal lease agreement or change of address receipt from Canada Post or any other document that proves residency at that address and (iii) a copy of all the drivers licenses of drivers residing at that address.

If you are a renter:

- Please have the property owner or administrator complete the *Attestation in support of application for overnight parking permit* form, which will confirm that access to on-property parking is not available. Include that with your application.

### **Conditions**

---

- (a) Permits are issued only to those who have insufficient driveway/garage space.
- (b) Any change of vehicle or plate number, including temporary use of a loaner/rental car, must be reported.
- (c) The sticker must be applied to the inside of the rear window, top centre.

Failure to comply with these conditions could result in the permit being void and the vehicle liable to a parking fine.
